The time allocated to registered objectors or supporters is strictly limited to five minutes. When more than one person has registered to speak to object or support a planning application, those persons registered to speak must divide the five minutes between them or nominate a group spokesperson. The Governance Officer will discuss arrangements that will be required to coordinate your presentation (including consenting to share your contact details).

What format will the meeting take?

The meeting will be an in-person meeting, with active speaking participants (applicants, objectors, supporters and Members) being present in the Town Hall.
